30 years of experience in International Development and Microfinance with Congress, State Department, Peace Corps, and the non-profit sector - living, working, and traveling in more than 60 countries to evaluate the effectiveness of international programs and to promote financial inclusion.

Founding CEO, Capital Sisters International (1998 to the present)

Founded Capital Sisters, a non-profit social enterprise, to provide grants, loans, and loan guarantees to Microfinance Institutions (MFIs) that serve impoverished women in developing countries; helped establish seven domestic and international MFIs under the Capital Sisters umbrella, raising funds for tens of thousands of women's micro loans in 25 countries since 1998; launched an innovative Impact Investment Fund that sells \$1,000 zero-interest bonds (Sister Bonds[®]) to socially responsible investors, raising more than \$2 million dollars for micro loans in Guatemala and the Philippines from the inaugural offerings.
